1. Purpose of this Notice

This Newsletter Consent Notice explains how CDE processes personal data when a person subscribes to, requests, confirms, receives or unsubscribes from CDE newsletter communications.

This notice should be read together with the CDE Personal Data Privacy Policy and any specific consent text displayed at the point of subscription.

2. Newsletter Content

CDE newsletters may include information about CDE activities, public statements, publications, events, projects, cooperation opportunities, organisational updates, document releases, news, announcements and other information related to CDE's mission and public-interest activities.

3. Personal Data Processed

For newsletter purposes, CDE may process the following personal data:

- email address;
- name, where provided;
- organisation or role, where voluntarily provided;
- language preference;
- subscription date and consent record;
- unsubscribe status and communication preferences;
- technical delivery information necessary to send and secure email communications.

4. Legal Basis

Newsletter communications are generally sent on the basis of consent, where the subscriber has actively requested or confirmed receipt of the newsletter. Where applicable, CDE may also send limited organisational communications on the basis of legitimate interests, provided this is lawful and proportionate and the recipient has a clear right to opt out.

Consent may be withdrawn at any time without affecting the lawfulness of processing carried out before withdrawal.

5. Consent Statement

By subscribing to the CDE newsletter, the subscriber consents to receiving electronic communications from CDE regarding its activities, publications, announcements, documents, events, cooperation initiatives and related organisational information.

6. Withdrawal and Unsubscribe

Subscribers may unsubscribe at any time by using the unsubscribe link provided in newsletter emails, where available, or by contacting CDE at the email address stated below. After unsubscribing, CDE may retain a minimal suppression record to ensure that the subscriber is not contacted again for newsletter purposes.

7. No Sale of Subscriber Data

CDE does not sell, rent or trade newsletter subscriber data. Subscriber information may only be shared with service providers where necessary to manage newsletter delivery, security, hosting, email dispatch or compliance, subject to appropriate confidentiality and data protection safeguards.

8. Retention

Newsletter subscription data is retained for as long as the subscription remains active and for a reasonable period thereafter where necessary for compliance, record keeping, consent verification, dispute handling or suppression-list management.

9. Rights of Subscribers

Subscribers may exercise GDPR rights, including the right of access, rectification, erasure, restriction, objection and withdrawal of consent, subject to applicable legal conditions and limitations.

10. Security

CDE applies reasonable organisational and technical safeguards to protect newsletter data against unauthorised access, disclosure, alteration, loss or misuse.

11. Updates

CDE may update this Newsletter Consent Notice from time to time. The latest version published on the CDE website shall apply.
